
New Sports Hall and Classrooms Opening October 2018

To mark the opening of this wonderful new facility at Henlow Church of England Academy, we are launching a 'Buy a Brick' campaign.


This means that all those taking part, whether students past or present, parents, staff, local community members or businesses, will have their own engraved brick slip hung inside the building as a permanent acknowledgement of their support.



Each brick can be engraved (up to four lines with a maximum of 16 characters per line including punctuation and spaces) with your name, your child's name or perhaps someone else in your family. If you are a former pupil you may wish to add the years you were a pupil here. The donation per brick slip is a minimum of £40 for single bricks (two lines) and £80 for double bricks (four lines). There is no limit to the number you can buy.




